High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

What we are doing

As part of our early environmental works, we are undertaking ecological surveys and fencing works in areas off Lichfield Road- A515. These works are required to demarcate and secure land under possession by HS2.

Balfour Beatty will be using flatbed road vehicles and trailers to deliver material as required to the working area.

We will need to install temporary two-way traffic lights on Lichfield Road- A515 at Bromley Hayes, to manage the safe movement of the vehicles and people into the working areas.

When the work take place?

We will put the traffic lights in place from **Wednesday 13th to Friday 22nd September 2023 9am-5pm.**

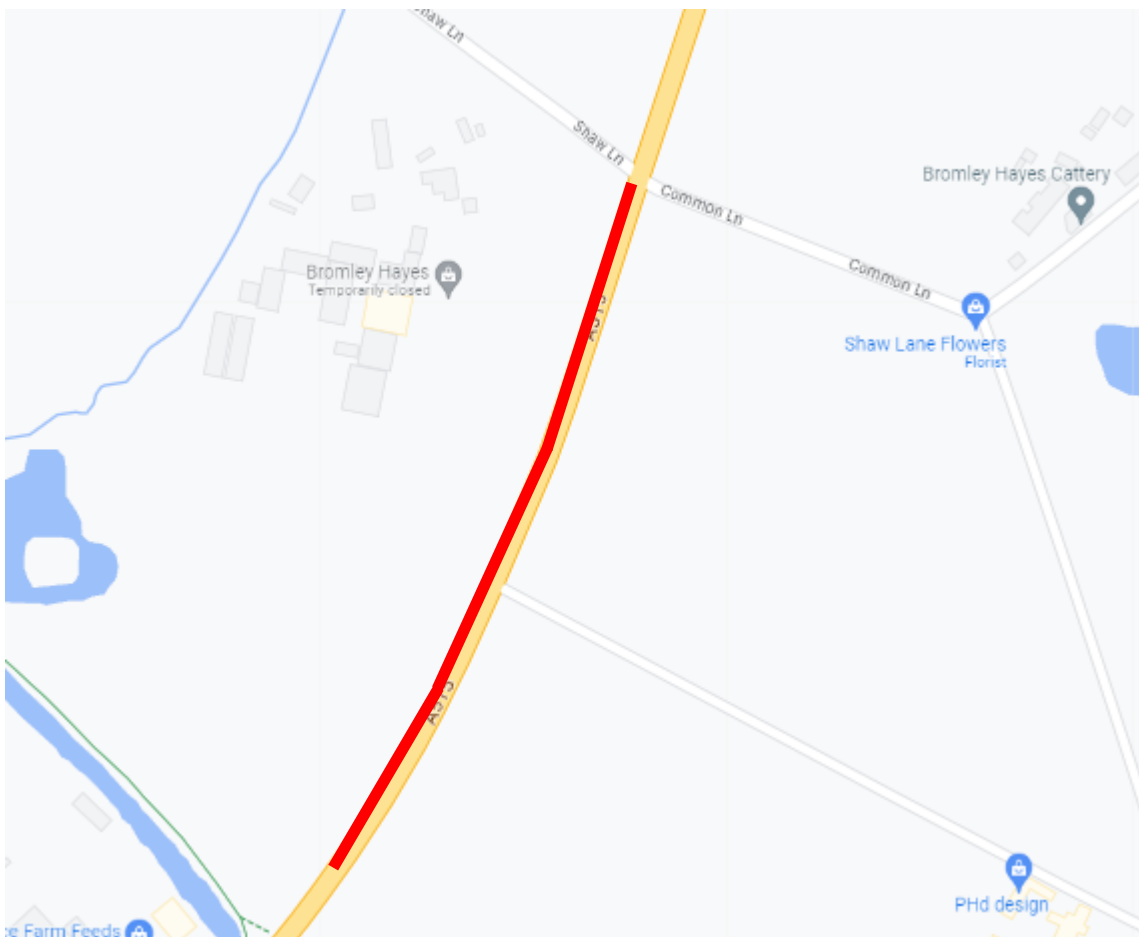

What to expect

The equipment we use may generate some low-level noise, we will be switching off engines when not in use and working during the day to minimise disruption to local residents. We will ensure the traffic lights are only in operation during periods when work is being undertaken to minimise disturbance.

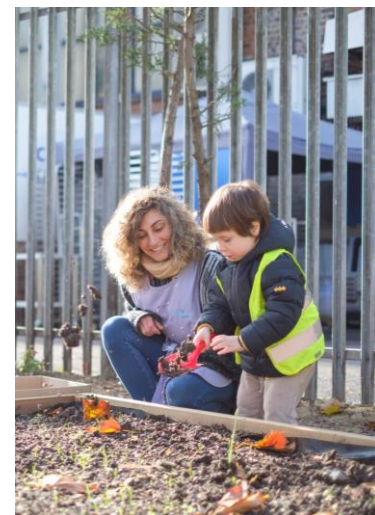
About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
