



# Notice of piling works near the A38 northbound at Streethay

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be undertaking

We will begin piling works on land near to the A38 northbound. These works will enable us to begin the construction of the new HS2 line to pass underneath the A38. Piling involves driving deep, strong columns into the ground to provide a solid base for our future structures.

## When the work will take place

The piling works will begin on 29 February and will be carried out in two phases:

### Phase One

From the 29 February until 4 April 2024, our working hours will be from 8am until 10pm. Our work will be carried out Monday to Friday.

This will include an additional two-hour shut down period, each night.

### Phase Two

From the 18 March until 15 May 2024, we will have a second team on site. Working hours for this section of work will be 8am until 6pm Monday to Friday.

Should we need to carry out any maintenance work this will be done on the weekends. From 1pm until 6pm on Saturday and 10am until 5pm on Sunday

## Duration of works

Piling works on land near the A38 northbound. From 29 February until 15 May, will be carried out in two phases.

### Phase One

29 February until the 4 April 2024. Our working hours will be 8am and 10pm Monday to Friday.

### Phase Two

18 March until the 15 May 2024. Our working hours for this section of work will be 8am until 6pm Monday to Friday.

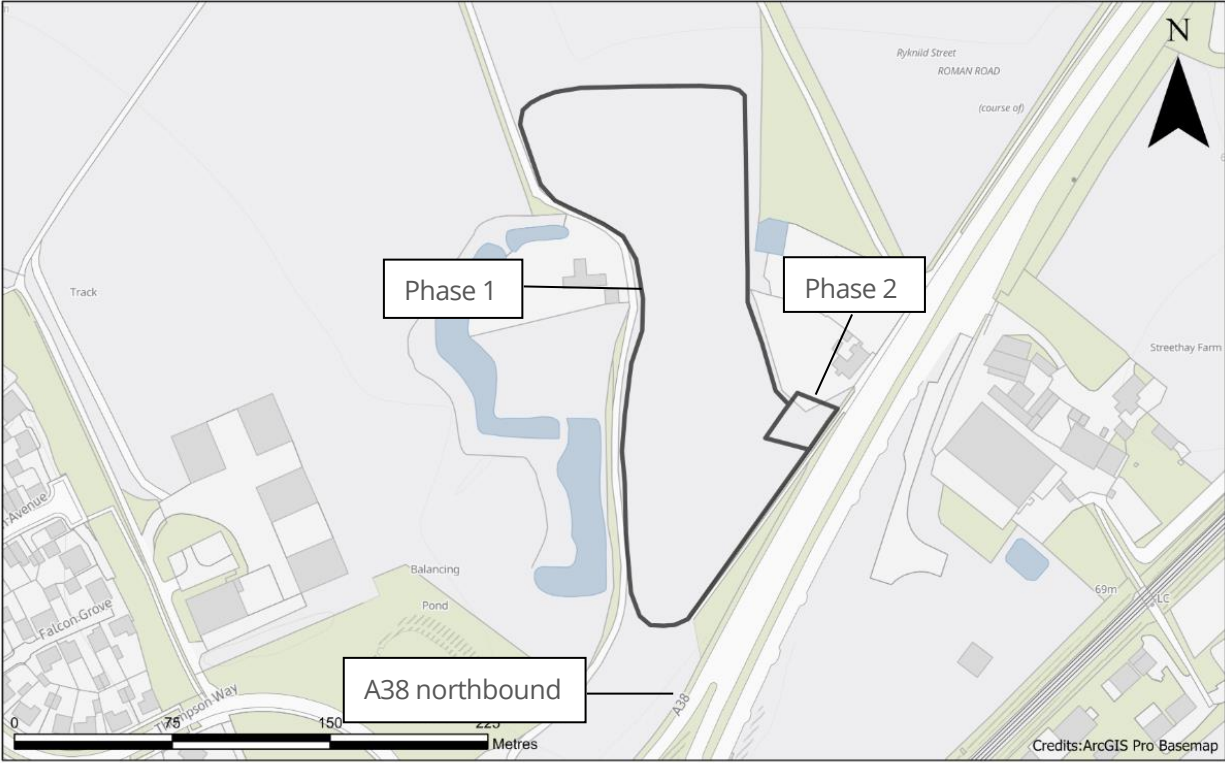
